# New Catholic OneCard from



Catholic University is transitioning Procurement and Corporate Cards from Truist Bank to the **Catholic U OneCard** with **J.P. Morgan Bank (JPM)**.

All current Truist PCard Users AND Approvers, as well as brand, spanking new applicants, must apply for their **JPM OneCard** online using **PaymentNet**, the **JPM** online portal beginning

**Tuesday September 3, 2024 (the day after Labor Day)**

The online application will be made available on Procurement & Payment Services (P&PS) website and in upcoming P&PS INFORMATION BULLETINS.

- 🦉 All applications will be routed to designated School/Department approvers for review and approval.
- 🦉 Once approved, the **Catholic U OneCard** will take 3 to 5 days to arrive at the P&PS Office in Leahy Hall Room 150. Cardholder will be contacted for pick up.
- 🦉 Approved Applications are required to successfully attend a live or virtual session **"OneCard Orientation Training"** before picking up their new **Catholic U OneCard**. Multiple sessions will be available throughout the month of September beginning the week of September 8<sup>th</sup>, 2024. Sign up on our P&PS Training Calendar (click [here](#)) beginning September 3<sup>rd</sup>.

Current Truist Cards will remain active throughout the month of September to provide a transition period. All Truist Cards will be deactivated on

**Monday, September 30th, 2024.**

Please apply for your new **Catholic U OneCard** through JPM as soon as available to avoid any business disruption.







**IMPORTANT NOTE:** The eligibility criteria for the University Card program has changed. Current Truist Card holders with infrequent usage (i.e. four (4) or less transactions per year), will **not** be eligible for a new **Catholic U OneCard**.

Additionally, all future **Catholic U OneCard** holders will be annually reviewed for frequency of activity. OneCard holders with infrequent activity will be deactivated. P&PS will propose alternative solutions available for procurement needs.
